

MANAGEMENT COMPANY AGREEMENT

AGREEMENT made and entered into as of (date) _____/_____/202__ by and between _____ (hereinafter referred to as "Talent") and WWW.supermodeling.TV is in part a Management Company (hereinafter referred to as "Manager").

In consideration of the mutual covenants and conditions herein contained, the parties agree as follows:

FIRST: Payment for acting services;

Talent will receive _____% of the Net for acting and or modeling services rendered for the project offered according to the signed date of this agreement.

SECOND: Additional video's;

Talent may receive 3 offers for additional video filming.

THIRD: Relationship;

It is understood and agreed that the relationship between Manager and Talent is that of independent contractors, and not an employment relationship. Talent shall be responsible for Talent's own Worker's Compensation, State Disability or State Unemployment coverage. Talent hereby releases and holds harmless Manager from any and all claims and/or responsibility with respect to Workmen's Compensation, State Disability, Federal Income Tax, Social Security or State Unemployment coverage or benefits relating to Talent.

FOURTH: Representations and Warranties;

Talent hereby represents and warrants that Talent has the right to make and enter into this Agreement, and that Talent is not now under contract to any personal manager or agent or business agent or business manager with respect to Talent's services. Talent hereby affirms that Talent is over the age of eighteen.

FIFTH: Adult Release;

In consideration of my engagement as a talent, upon the terms herewith stated, I hereby further give to <http://www.Supermodeling.tv> owners heirs, legal representatives and assigns, those for whom <http://www.Supermodeling.tv> is acting, and those acting with its authority and permission:

a) the unrestricted right and permission to copyright and use, reuse, publish, and republish photographic portraits video, or pictures of me or in which I may be included intact or in part, composite or distorted in character or form, without restriction as to changes or transformations in conjunction with my own or a fictitious name, or reproduction hereof in color or otherwise, made through any and all media now or hereafter known for illustration, art, promotion. advertising, trade, or any other purpose whatsoever in perpetuity and indeed extending beyond the limits of the other specifications of this contract forever .

b) I also permit the use of any printed material in connection therewith.

c) I hereby relinquish any right that I may have to examine or approve the completed product or products or the advertising copy or printed matter that may be used in conjunction therewith or the use to which it may be applied.

d) I hereby release, discharge and agree to save harmless [manager], his heirs, legal representatives or assigns, and all persons functioning under his permission or authority, or those for whom he is functioning, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy.

e) I hereby affirm that I am over the age of majority and have the right to contract in my own name. I have read the above authorization, release and agreement, prior to its execution; I fully understand the contents thereof. This agreement shall be binding upon me and my heirs, legal representatives and assigns.

f.) Also I the undersigned acknowledge that I have full understanding that the ongoing project of promotion may be used in conjunction with any advertising of any and all types where it is considered advantageous in the opinion of the Management Company of <http://www.Supermodeling.tv> .

g.)
